A - The unanimous decisions on the issue of candidacies from Lebanon and on the issue of R I motion are as follows:

R II ZOOM PRESIDENTS MEETING DECISION FOR LEBANON MS

"The Member sections of Region II ,in their meeting on May 12 2021, unanimously decided to insist on the implementation of the Council's decision of February 25,2021, which exempted the Lebanese MS from paying the UIA fees for 2020 and 2021, and to request the Secretary General to withdraw his letter of April 29,2021, threatening, in case of non payment of the fees, to invalidate Lebanon's candidacies for the positions of President and Council Member"

R II ZOOM PRESIDENTS MEETING DECISION FOR REGION I MOTION

"The Member sections of Region II, in their meeting on May 12 2021, unanimously decided to endorse and support the Region I Motion presented by Eric Wirth from France and Lorenz Breaker Vice President of UIA Region I" B - The Letters co-signed and sent by the VPs s to the Council Members and the relevant answers from the UIA International officers, as per attached.

For reasons of deontology, my introductory speech will be sent to you in written form along with all other speeches and documents of participants who wish that I disseminate them to the R II member Sections' participants. I kindly ask to send them to me next week and and I will forward them to all along with the video recording of the whole meeting.

As a conclusion and in my opinion, our efforts for the next period should focus on eliminating the consequences deriving from the problems and the mistakes of the past and of the social distancing. We should meet no longer through virtual or hybrid meetings, but through live meetings and shake hands once again, with the aim to reconstitute a NEW Democratic, Transparent and Friendly atmosphere for the UIA future.

We should meet once again wherever is the light of Hope and Happiness!
